

# **USDA News**

## USDA Offers Disaster Assistance to Louisiana and Texas Farmers and Ranchers Impacted by Hurricane Laura

Hurricane Laura's flooding and high winds impacted agricultural operations in Louisiana and Texas, and the U.S. Department of Agriculture (USDA) has technical and financial assistance available to help farmers and ranchers recover. As agricultural producers move into recovery mode and assess damages, they should contact their local USDA Service Center to report losses and learn more about program options available to assist in their recovery from crop, land, infrastructure and livestock losses and damages.

"FSA has a variety of disaster assistance programs to support farmers and ranchers through times of adversity," said Craig McCain, state executive director for USDA's Farm Service Agency (FSA) in Louisiana. "Once you are able to evaluate impacts on your operation, it is important to contact your local FSA office to timely report all damages and losses and determine how we can assist."

USDA encourages farmers and ranchers to contact the FSA county office at the local USDA Service Center to learn which documents should be provided to help the local office expedite assistance, such as farm records, receipts and pictures of damages or losses.

Depending on the operation, FSA offers a number of disaster assistance programs to help offset eligible losses, including the Livestock Indemnity Program, Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program, Emergency Conservation Program, Emergency Forest Restoration Program, Noninsured Crop Disaster Assistance Program (NAP) and Tree Assistance Program.

Additionally, producers located in counties with a primary or contiguous disaster designation may be eligible for low-interest emergency loans to help them recover from production and physical losses.

USDA's Natural Resources Conservation Service (NRCS) also offers programs to help in the recovery process. The Environmental Quality Incentives Program (EQIP) can help producers plan and implement conservation practices on land impacted by natural disasters.

"NRCS can be a very valuable partner to help landowners with their recovery efforts," said Chad Kacir, state conservationist for the NRCS in Louisiana. "Our staff will work one-on-one with landowners to make assessments of the damages and develop approaches that focus on effective recovery of the land."

Additional NRCS programs include the Emergency Watershed Protection (EWP) program, which provides assistance to local government sponsors with the cost of addressing watershed impairments or hazards such as debris removal and streambank stabilization. Eligible sponsors include cities, counties, towns, conservation districts or any federally recognized Native American tribe or tribal organization. When a watershed impairment occurs due to a natural disaster event, the district conservationist serves as the local facilitator for EWP activities. The Federal Emergency Management Agency (FEMA) is the lead federal agency for Presidentially declared natural disasters. All NRCS emergency work is coordinated with FEMA or its designee. Sponsors must submit a formal request (via mail or email) to the state conservationist for assistance within 60 days of the natural

disaster occurrence or 60 days from the date when access to the sites become available. For more information, please contact Britt Paul, EWP program manager, at britt.paul@usda.gov or (318) 473-7756.

Producers with Federal crop insurance coverage should contact their crop insurance agent for assistance. Producers should report crop damage to their agent within 72 hours of damage discovery and follow up in writing within 15 days.

"Crop insurance is there to help producers manage risk because we never know what nature has in store for the future," said Roddric Bell, director of RMA's Regional Office that covers Louisiana. "The Approved Insurance Providers, loss adjusters and agents are experienced and well trained in handling these types of events."

# **CONSERVATION CONVERSATION** Fall Food Plots for Wildlife



Planting a fall food plot on your farm or ranch will help provide food for wildlife during winter months when food is sometimes scarce. Food plots also help to maintain wildlife populations and add value to your land.

To establish a food plot in an existing field, leave several rows of grain after harvest—or you can plant a small plot in a separate location.

#### A few things to consider when developing your wildlife food plot:

Will the food plot you provide attract the wildlife you want?

Is there enough cover and water near the food plot?

Is the food plot too close to high traffic areas?

Are using conservation measures to prevent erosion when you plant your food plot?

Have you excluded livestock from the area?

Planting dates vary from crop to crop. The **Supplemental Wildlife Food Planting Manual for the Southeast**, published by Mississippi State University Extension Service recommends the following planting dates:

Austrian Winter Peas – Planting Dates September 1 – November 1

**Crimson Clover** – Planting Dates September 1 – October 15

**Subterranean Clover** – Planting Dates August 15 – October 15

White or Ladino Clover – Planting Dates September 1 – October 15

**Rye** – Planting Dates August 15 – October 15

**Oats** – Planting Dates August 15 – October 15

Customers can track payments, report completed practices, request conservation assistance and electronically sign documents.

The U.S. Fish and Wildlife Service administratively manages the Mississippi Flyway through the Mississippi Flyway Council. Council members represent the states of Alabama, Arkansas, Indiana, Illinois, Iowa, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Ohio, Tennessee, and Wisconsin, and the Canadian provinces of Saskatchewan, Manitoba, and Ontario.

The National Audubon Society calls the Mississippi Flyway a "River of Birds." They report that more than 325 bird species make the round trip each year along the Mississippi Flyway from their breeding grounds in Canada and the northern United States to their wintering grounds along the Gulf of Mexico and in Central and South America.

**Waterfowl Facts** 

- Most ducks fly at 40 to 60 miles per hour.
- Mallards are capable of traveling 800 miles in 8 hours.
- In January 1940 a biologist reported seeing as many as 8 million ducks in Louisiana on Catahoula Lake.
- Waterfowl can see everything above, below, in front of, and behind them at the same time.
- The fastest duck recorded was a red-breasted merganser that got up to 100 miles per hour while being chased by an airplane.
- A blue-winged teal banded near Oak Lake, Manitoba, was shot by a hunter Lima, Peru, more than 4,000 miles south.
