

# Conservation Conversation



**Prescribed burning** is a forestry management tool used to remove low-growing vegetation from the forest floor. By removing the low-growing vegetation, wildfire risk is reduced, wildlife habitat is improved, weeds are controlled. and the health of the forest stand is improved.

Prescribed fire controls undesirable vegetation; prepares sites for planting or seeding; controls plant disease and insects: removes slash and debris:

enhances seed and seeding production; facilitates distribution of grazing animals; and restores native plant communities.

There are many things to consider when using fire as a forest management tool, including fuel, burning techniques, proper tools, weather, smoke, liability, fire behavior, local fire regulations, and more. When using fire as a forestry management tool, it is important to work with a certified prescribed burner.

The USDA Natural Resources Conservation Service (NRCS) can help you assess your forestland, develop a conservation plan, and plan for a prescribed burn. There is no charge for their assistance. Louisiana Certified Prescribed Burner Program

In 1993 the Louisiana Legislature passed Act 589 authorizing the Louisiana Department of Agriculture and Forestry to implement and administer the Louisiana Certified Prescribed Burner program. Certified Prescribed Burner Training is offered by the LSU AgCenter. To learn more about the training, contact your local Cooperative Extension Service office.

### USDA Streamlines Agricultural Conservation Easement Program

The U.S. Department of Agriculture (USDA) is streamlining its Agricultural Conservation Easement Program (ACEP). Specifically, NRCS is updating its processes around appraisals, land surveys, as well as certifying eligible entities who help NRCS and producers enroll land into easements. These changes are for **ACEP Agricultural Land Easements** (ALE) as well as Wetland Reserve Easements (WRE). NRCS is streamlining ACEP appraisals, land surveys, as well as certifying eligible entities who help NRCS and producers enroll land into easements.

ACEP is administered by NRCS and aids landowners and eligible entities with conserving, restoring, and protecting wetlands, productive agricultural lands, and grasslands at risk to conversion to non-grassland uses.

NRCS accepts producer applications for its conservation programs – including ACEP – year-round. Producers interested in easements should contact their local NRCS office. To find your local office, go to: https://www.nrcs.usda.gov/contact/find-a-service-center.

### Two Louisiana WREP Projects Approved

The U.S. Department of Agriculture (USDA) is investing \$17 million in five Wetland Reserve Enhancement Partnership (WREP) projects, bringing together partners and landowners in a joint effort to return critical wetland functions to agricultural landscapes. Two of the five projects include Louisiana wetlands.

### Louisiana's 2023 WREP projects:

#### The Nature Conservancy -Tri-State Conservation

**Partnership** (enrollment goal – 1,500 acres): This project focuses on enrolling underserved landowners and restoring forested wetlands within priority portions of the Mississippi Alluvial Valley (MAV) in Arkansas, Louisiana and Mississippi.

Mississippi River Trust - Lower Batture (enrollment goal – 2,000 acres): This project aims to achieve more sustainable land and water management in the river's active floodplain, or Batture, and nearby flood-prone lands in Arkansas, Louisiana, and Mississippi.



### LDWF Announces: Applications Open for Alligator Lottery Harvests

The Louisiana Department of Wildlife and Fisheries (LDWF) will conduct alligator lottery harvests on 21 LDWF Wildlife Management Areas (WMAs), 28 public lakes and one U.S. Army Corp of Engineers (USACE) property Aug. 30-Nov. 4, 2023. Applications are now available and are due by June 30.

Alligator lottery applications are only available on the LDWF website at https://louisianaoutdoors.com/lott ery-applications. To apply click on the Lottery Applications tab,

the Lottery Applications tab, update or create customer details similar to purchasing a license and then submit an application. There is a \$5 application fee and a \$5 transaction fee.

Only one alligator lottery application may be submitted per customer. Applicants must be legal Louisiana residents and 16 years of age or older. If selected, you will be required to purchase an alligator hunter license (\$25) and to submit payment of \$40 for each alligator tag allocated. Do not purchase the alligator sport hunter license available online as this license type is not applicable to these lottery hunts.
