promotes land management practices that allow for the harvest of trees while enhancing the environment for wildlife and clean water and planting new trees for the future.



Becoming a Louisiana Master Logger shows today's competitive market that you care about being environmentally responsible.

Master Logger designation has great potential to be beneficial to your business—you enhance your company's reputation, gain access to new markets and promotional opportunities, and gain access to training and industry trends—all while ensuring the sustainability of Louisiana's forests. All logging contractors and foremen should participate in the Louisiana Master Logger Program.

To become a certified Master Logger in Louisiana you must attend two days of initial classes, then earn a minimum of 6 continuing education credits each year thereafter to remain certified.



### Local News from LDWF and LDAF

### LDWF Expands CWD Testing Drop-off Locations in Catahoula, Concordia, Morehouse and Union Parishes from the LDWF News Room

The Louisiana Department of Wildlife and Fisheries (LDWF) has added six new Chronic Wasting Disease (CWD) drop-off locations in Catahoula, Concordia, Morehouse and Union parishes for deer hunters to submit CWD samples for testing. These new locations are in addition to the seven established last season within Franklin, Madison and Tensas parishes in response to the detection of CWD within Tensas Parish.

Important Reminder: Deer heads from deer harvested within the CWD Control Area, which consists of Tensas Parish and portions of Concordia, Franklin and Madison parishes, may not be transported outside of the control area. Hunters harvesting deer from outside the control area may utilize the newly added drop-off locations as well as the drop-off locations within the control area.

Chronic Wasting Disease (CWD) is a neurodegenerative disease of white-tailed deer and other members of the family Cervidae. It is caused by a prion, an infectious, misfolded protein particle, and is 100% fatal in affected deer after an indeterminate incubation period. There is no treatment or preventative vaccine for CWD.

### Succession Law


Louisiana laws regarding the transfer of property to your heirs at death are very different from other States' laws.

About Heirs' Property - from farmers.gov

Heirs' property is family owned land that is jointly owned by descendants of a deceased person whose estate did not clear probate. The descendants, or heirs, have the right to use the property, but they do not have a clear or marketable title to the property since the estate issues remain unresolved.

Land is passed down without a will or deed to prove ownership. Each successive generation generally results in more heirs being added to the land inheritance. The absence of the deed or will becomes more complicated and grows by generation as time and people pass.

Without proof of ownership, it may become difficult for heirs to obtain federal benefits for farms and could also force partition sales by third parties.


